New Chinese investments in Lubuskie (Szprotawa)



Plans to build a Kingfa factory, which is a supplier of granulate made of biodegradable, environmentally friendly plastics used in the following industries: household appliances, automotive and electronics. The Szprotawa plant will employ 100 people, and ultimately 400 people. A Scientific and Research Centre for the production of new technologies will also be established.

The opening of the plant and the start of production are planned for the turn of 2024/2025.

The investment cost is PLN 60 million.



New Chinese investments in Lubuskie (Szprotawa)



In 2022, the Minth Group which in 2023 began producing electrical and electronic equipment for motor vehicles and components for electric cars (including for the Mercedes and Volvo brands).

Initial employment was 70 people, and ultimately 500 people are to be employed at the factory. The Group has committed to invest approximately PLN 416 million in Wiechlice.
